Dr. Chris Anderson graduated from Palmer College of Chiropractic in 2011, where he earned innumerable awards and honors. He then joined his father at Anderson Chiropractic Clinics, later taking over the business and growing it into Anderson Integrative Clinics and Motiv8 Children's Therapy. He traveled all over the country to teach clinicians and their teams how to reach their maximum potential and he imparted his knowledge in ways that no one else could.

He was especially proud of his international outreach through the Palmer Clinic Abroad Program, where he provided care to underprivileged patients in many countries including Vietnam, India, South America and Fiji. In 2023 Chris was honored as the "Chiropractor of the Year" from the Chiropractic Society of Wisconsin.

Chris leaves behind a legacy of kindness and dedication to his family and friends. His imprint is lasting in the Chiropractic profession as well as the Reedsburg community, but spreads far beyond.
