The Legacy of Leadership Scholarship is a \$5,000 award presented annually to a deserving chiropractic student at the ChiroCongress Convention, taking place November 5-7, 2026.

### **About Dr. Ray Foxworth**

A second-generation chiropractor from Yazoo City, Mississippi, Dr. Foxworth is a 1985 graduate of Cleveland University–Kansas City and has spent nearly four decades shaping the future of chiropractic care. He is best known as the founder and CEO of ChiroHealthUSA, where his experience with billing, coding, documentation, and compliance inspired him to create a solution that supports both providers and patients.

Dr. Foxworth's career includes serving as Staff Chiropractor at the G.V. Sonny Montgomery VA Medical Center, past chairman of the Chiropractic Summit, and former chairman of the Mississippi Department of Health. In addition, he practiced for 35 years at Foxworth Chiropractic at NewSouth NeuroSpine in Flowood, Mississippi, where he cared for thousands of patients with compassion, expertise, and integrity.

His commitment to service extends far beyond clinical care. Dr. Foxworth currently serves as an at-large board member of the Chiropractic Future Strategic Plan, a past member of the Cleveland College Foundation board, and an executive board member of the Foundation for Chiropractic Progress. His leadership, generosity, and steadfast dedication have left a lasting imprint on the profession.
